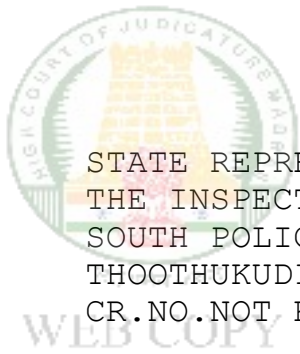

ORDER : The Court Made the following order :-

COMMON ORDER

The petitioner apprehends arrest at the hands of the respondent police for the offences punishable under Sections 147, 148, 353, 188, 436 and 506(ii) IPC and Sections 3 and 4 TNPPDL Act in Crime No.Not Known of 2018, seeks anticipatory bail.

2.Heard the learned counsel appearing for the petitioner and the learned Additional Advocate General appearing for the respondent Police.

3.One Krishna Moorthy is the petitioner in all these petitions. His apprehension of arrest is in connection with the cases registered on 22.05.2018 pertaining to anti-sterlite protest.

4.When the matter was taken up for hearing, the learned Additional Advocate General submitted that the petitioner's name is not revealed in the First Information Report.



5. Till date no FIR has been registered against him. If petitioner gets implicated, the petitioner would be given notice under Section 41 (A) Cr.P.C. Then, the petitioner will have breathing time to approach this Court.
