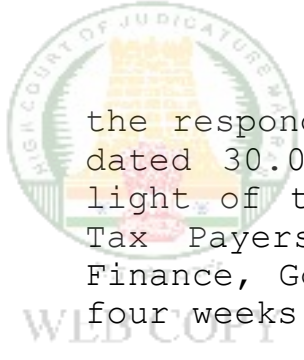
2. Mr.B.Vijayakarathikeyan, learned Central Government Standing Counsel takes notice for the respondents.
