PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offence punishable under Sections 141, 294 (b), 323, 324 and 506(ii) of I.P.C., in Crime No.120 of 2018, on the file of the respondent police, seeks anticipatory bail.

2. In this case, the victim was stabbed. Therefore, the petitioner undertakes to pay him a sum of Rs.5,000/- towards medical expenses.

3. Recording the said undertaking, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on their appearance before the learned Judicial Magistrate No.II, Ramanathapuram District and executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioner shall appear before the respondent police as and when required for interrogation. The petitioner shall comply with the conditions stipulated under Section 438 Cr.P.C. Scrupulously.



made ready, failing which, the petition for anticipatory bail shall stand dismissed.
