2. Heard Mr.A.R.Kannappan, learned Counsel appearing for petitioner, Mr.M.Karuppasamy, learned Government Advocate appearing for the respondents 1 to 3 and Mr.B.Thanga Aravindh, learned Counsel appearing for the fourth respondent.

3. The learned Government Advocate appearing for the respondents 1 to 3 would submit that the parties concerned appeared for the Peace Committee Meeting before the Tahsildar. It is further submitted that the dispute among the parties have been resolved in the aforesaid Peace Committee Meeting and the proceedings of the Tahsildar, Vembakottai Taluk, Virudhunagar District in Na.Ka.No.A1/1785/2018 dated 23.07.2018 has also been placed before this Court.
