2.Heard both sides.

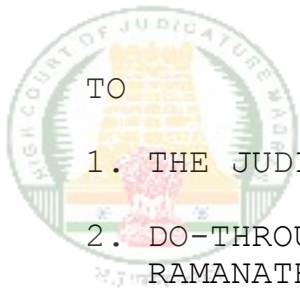
3.Considering the facts and circumstances of the case, the condition already imposed on the petitioner is fully relaxed.
