PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners apprehending arrest at the hands of the respondent police for the offence punishable under Sections 147, 294 (b), 323, 355 and 506(i) of IPC., and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002, in Crime No.404 of 2018, on the file of the respondent police, seek anticipatory bail.

2.The learned Government Advocate (Criminal side) submitted that the injured has been discharged from the hospital.

3. Considering the facts and circumstances of this case, this Court is inclined to grant anticipatory bail to the petitioners with certain conditions. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on their appearance before the learned Judicial Magistrate, Melur and executing a bond each of them for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two common sureties each for a like sum to the



satisfaction of the learned Magistrate concerned and on further condition that the petitioners shall appear before the respondent police as and when required for interrogation. The petitioners shall comply with the conditions stipulated under Section 438 Cr.P.C. Scrupulously.
