Prayer in CMA(MD) No.SR4355 of 2016:-

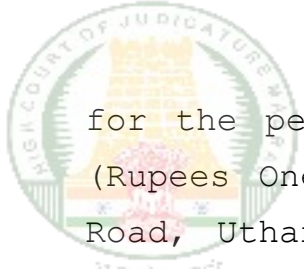
