(Order of the Court was made by C.T.SELVAM,J.)

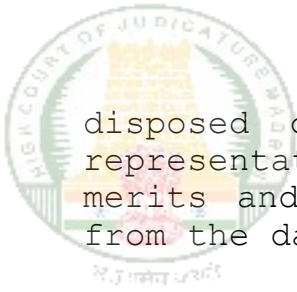
By consent, Writ Petition itself, is taken up for final disposal.
