3. Under such circumstances, we direct the first respondent to consider the representation of the detenu's grandson and to pass suitable orders thereon on merits and in accordance with law, within a period of three months from the date of receipt of a copy of this order.

4. With the above directions, this Habeas Corpus Petition is disposed of.

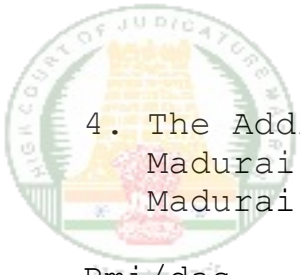
