**ORDER**

2.Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the respondents.

4.The learned Additional Government Pleader appearing for the respondents would submit that the representation of the petitioner would be considered by the respondents on merits and in accordance with law within the time to be stipulated by this court.

5.By considering the facts and circumstances of the case, without expressing any opinion on the merits of the case, this Court is inclined to direct the third respondent to consider the petitioner's representation, dated 17.07.2018 on merits in accordance with law on or before 02.08.2018.

6.With the above direction the Writ Petition is disposed of. No costs.
