Prayer in CMA(MD) . 562/2015 :

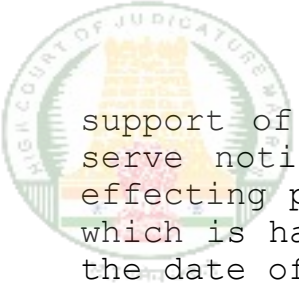

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.A.SARAVANAN, Advocate for the petitioner and of MR.S.SRINIVASA RAGHAVAN, Advocate on behalf of the 2nd Respondent, the court made the following order:-

This petition has been filed by the petitioner / claimant seeking permission of this Court to order service of notice on the 1st respondent in C.M.A.(MD).No.562 of 2015 by means of substituted service.
