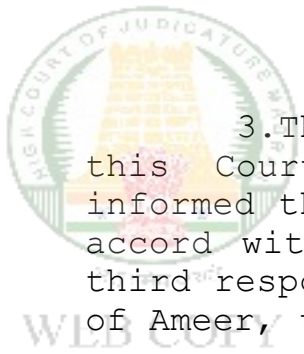

3.The second respondent has produced the detenue before this Court. The petitioner is also present. The petitioner informed that the detenue having left her parental home on her own accord with one Ameer to Chennai. But on being contacted by the third respondent, who had done so using the services of the friend of Ameer, they have appeared before the third respondent.

The petitioner is informed of such position. The detenue informs that she will, for the present, accompany the petitioner to the parental home, ofcourse, the same was agreed by the petitioner.
