PRAYER IN CMA(MD) No.SR30266 of 2016:

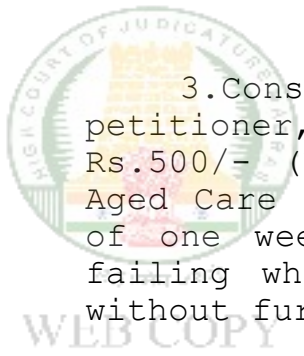
To set aside the Judgment and Decree of this Claims Tribunal in
