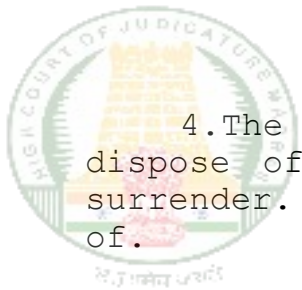
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under Sections 147, 148, 323, 324, 379 IPC r/w Section 3(1)(r), 3(1)(s) of the Scheduled Caste and The Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015 in Crime No.164 of 2018 on the file of the respondent police, seeks anticipatory bail.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent.

3.The petitioner is permitted to surrender before the Jurisdictional Special Court within a period of two weeks from the date of receipt of a copy of this order. The petitioner is permitted to inform the defacto complainant by a registered post regarding his date of surrender, when he applies for regular bail.



4. The jurisdictional Special Court is directed to consider and dispose of the petitioner's bail application on the same day of surrender. Accordingly, this Criminal Original Petition is disposed of.
