Hence, the present writ petition is filed.

4.In view of the limited prayer sought for in the writ petition, without going into the merits of the matter, this Court is inclined to direct the second respondent to consider the petitioner's representation dated 26.07.2018 on merits and in accordance with law, on or before 08.08.2018.
