3.According to the petitioner, he made a representation, dated 23.07.2018, seeking to permit the petitioner to conduct the "Karakaattam" programme which is scheduled to be held on 05.08.2018 between 10.00 a.m. and 05.00 p.m. at Arulmigu Sree Aalayi Amman Kovil at Thuvakudi Village, Trichy District and to provide adequate police protection. No order has been passed till date. Hence, the petitioner filed this present writ petition before this Court.
