2.This Court while granting anticipatory bail, directing the petitioner to surrender before the Jurisdictional Magistrate. The learned counsel for the petitioner would submit that the defacto complainant threatened the petitioner with dire consequences. Therefore, he sought for modification to produce the sureties before



the learned Judicial Magistrate No.I, Krishnagiri.

3.This Court consider the request made by the petitioner and inclined to modify the condition. Accordingly, the petitioner is directed to appear before the learned Judicial Magistrate, Periyakulam and produce the sureties within a period of two weeks from today.

4.Accordingly, this Criminal Miscellaneous Petition is allowed.
