PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners apprehending arrest at the hands of the respondent police for the offences punishable under Sections 406, 417 and 420 of IPC, in Crime No.14 of 2015, seek anticipatory bail.

2.Heard the learned counsel for the petitioners and the learned Government Advocate (Crl.Side) for the respondent.

3.The defacto complainant has paid a few lakhs of rupees to the petitioner, since the petitioner had assured him that an overseas employment will be arranged. But, he had sent him only in a form of Tourist Visa for a week. Therefore, this FIR came to be registered. This Court already granted anticipatory bail to the petitioner's father since the primary allegation only against this petitioner.

Now, taking advantage of the grant of the anticipatory bail to the petitioner's father, the petitioner has come forward with this



petition. Since there are direct allegations made against the petitioner and a few lakhs of money involved in this case, this Court is not inclined to grant anticipatory bail to the petitioner.
