ORDER : The Court Made the following order :-

The petitioners apprehending arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 323 and 506(ii) of IPC r/w 3(1)(r) and 3(2)(va) of the Scheduled caste and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015, in Crime No.424 of 2018, on the file of the respondent police, seeks anticipatory bail.

2.Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl.Side) appearing for the respondent.

3.The petitioners are permitted to surrender before the Jurisdictional Special Court within a period of two weeks from the



date of receipt of a copy of this order. The petitioners are permitted to inform the defacto complainant by a registered post regarding his date of surrender, when he shall apply for regular bail.

4. The Special Court is directed to consider and dispose of the petitioner's bail application on the same day of surrender.

5. Accordingly, this Criminal Original Petition is disposed of.
