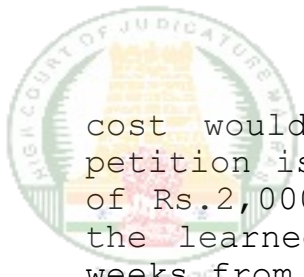
The learned counsel for the respondent states that the delivery has been effected through Court.

3. The conduct and attitude of the learned counsel for the respondent is peculiar. This Petition has been filed to extend the time granted in M.P.(MD).No. 3 of 2013 in C.R.P.(MD).No. 254 of 2013, dated 24.07.2015, wherein, this Court directed the petitioner to deposit a sum of Rs.2,000/- within a period of two weeks from the date of order. It is stated that the respondent has refused to accept the money and that, he has filed lodgment schedule before the learned District Munsif Court, Musiri.
