JUDGMENT

[Judgment of the Court was delivered by M.M.SUNDRESH, J.]

The writ appeal is directed against the order of the learned Single Judge in the writ petition, in which he has dismissed the same inter alia holding that the appellant has not produced the certificate for passing 8th standard though he has completed 10th standard.

2. Heard Mr.C.Venkatesh Kumar, learned counsel appearing for the appellant and Mr.N.Shanmugaselvam, learned Additional Government Pleader appearing for the respondent.



3.Learned counsel appearing for the appellant would submit that 8th standard pass certificate has been produced subsequently. The learned Additional Government Pleader in turn would submit that the process of giving call letters has started.

4.Considering the above, we direct the respondent to accept the 8th standard pass certificate produced by the appellant and based upon the same issue call letter to him, if he is otherwise eligible.

5.Accordingly, this Writ Appeal stands allowed to the extent indicated above. Consequently, connected civil miscellaneous petition is closed. No costs.
