ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in C.C.No.459 of 2014 on the file of the learned Judicial Magistrate No.I, Kuzhithurai for the offences punishable under Sections 147, 148, 294(b), 323, 324, 379 and 506(ii) I.P.C, in Crime No.571 of 2013, seeks anticipatory bail.

2.The petitioner was absent during the trial in C.C.No.459 of 2014 on the file of the learned Judicial Magistrate No.I, Kuzhithurai. Therefore, Non-Bailable Warrant came to be issued.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

Considering the undertaking given by the petitioner, the petitioner is directed to appear before the learned Judicial Magistrate No.I, Kuzhithurai, within a period of two weeks from the date of receipt of a copy of this order and to file a petition to recall the NBW issued against him. The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
