In the mean while, both the petitioner and the other party against whom the allegation is made shall be put on notice before concluding the proceedings. 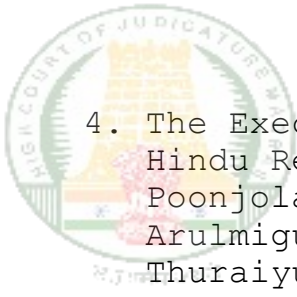
