PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner is shown as third accused. He was arrested and remanded to judicial custody on 04.06.2018 and 06.06.2018 respectively for the offences punishable under Sections 147, 148, 341, 307, 120(b) I.P.C r/w Section 4 of TNPPDL Act in Crime No.297 of 2018 on the file of the respondent police. He seeks bail.

2.The co-accused were granted bail by this Court in Crl.O.P. (MD) No.14077 of 2018 on 09.08.2018 and there were directed to pay a sum of Rs.25,000/- each.

3. The learned counsel for the petitioner submits that the petitioner is having some financial difficulties. He undertakes to deposit a sum of Rs.10,000/- to the credit of Crime No.297 of 2018. Subject to the said condition, bail is granted.

4.This Court is inclined to enlarge the petitioner on bail with certain conditions. Accordingly, the petitioner is ordered to be released on bail, subject to the following conditions;

(i) the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate, Vidasandur,



(ii) the petitioner is directed to deposit a sum of Rs.10,000/- to the credit of Crime No.297 of 2018.

(iii) on breach of any of the aforesaid conditions, the Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005) AIR SCW 5560].
