What is sought for in this Writ Petition is to reject the Nomination of the fifth respondent for the post of Director of the Society, which was held on 03.05.2018.

2. As already held by the Division Bench of the Principal Seat of this Court in **W.P.No.7526 of 2018**, etc., batch., dated **03.08.2018**, the remedy open to the petitioner is to approach the



Registrar of Co-operative Societies, under Section 90 of the Tamil Nadu Co-operative Societies Act, 1983.

3. In such view of the matter, we are not inclined to entertain the Writ Petition and accordingly, the Writ Petition is dismissed. However, liberty is given to the petitioner to exhaust the remedy, as indicated above. No costs.
