Prayer in CRL MP(MD). 6355/ 2018 :

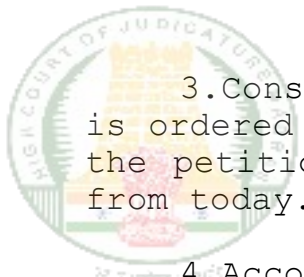
