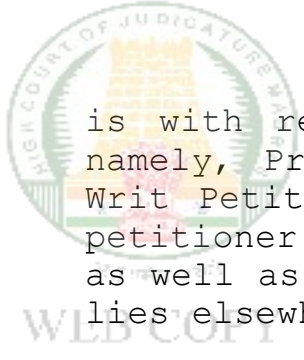

is with respect to the further election of the office bearers, namely, President, Secretary, etc. We are of the view that this Writ Petition cannot be entertained on mere apprehension. If the petitioner has got any grievance on the election already conducted as well as the future one, electing the office bearers, his remedy lies elsewhere.

2. The Writ Petition is dismissed with the above observation. No costs.
