However, considering the submissions made by the learned counsel for the petitioner the said condition is modified to the effect that the petitioner herein shall produce the vehicle before the trial Court on any one of the working day in the first week of every English calender month. Except this modification, all the other conditions stand confirmed.



4. With the above modification, these criminal revision cases are disposed of. Consequently, connected miscellaneous petitions are also closed.
