Registry is directed to number the restoration petition.

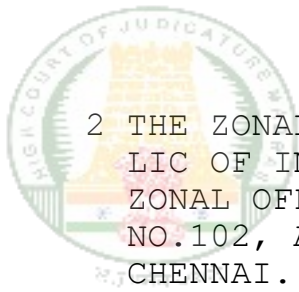
