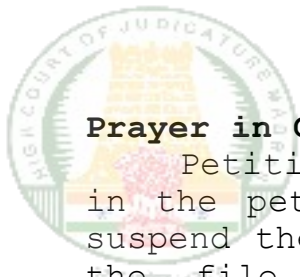

3.Considering the gravity of offence, this Court is not inclined to suspend the sentence at present. Accordingly, these petitions for suspension of sentence are dismissed.
