PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner/A3 apprehends arrest at the hands of the respondent police for the offences punishable under Section 379 of I.P.C., in Crime No.130 of 2015, seeks anticipatory bail.

2.The learned counsel appearing for the petitioner would submit that on 03.04.2017, due to illness, the petitioner was not able to appear before the learned Judicial Magistrate, Cheranmahadevi in respect of the case in C.C.No.29 of 2017 and hence, non bailable warrant has been issued against the petitioner. He would further submit that the said absence is neither willful nor wanton and he undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

3.Heard the learned Government Advocate (criminal side) appearing for the respondent.

4.Considering the undertaking given by the learned counsel for the petitioner, the petitioner is directed to appear before the learned Judicial Magistrate, Cheranmahadevi, within a period of 2 weeks from today and to file a petition to recall NBW already issued against him. On filing of such petition, the concerned learned Judicial Magistrate is directed to consider the same on merits and pass orders on the same day.



5. This criminal original petition is disposed of accordingly.
