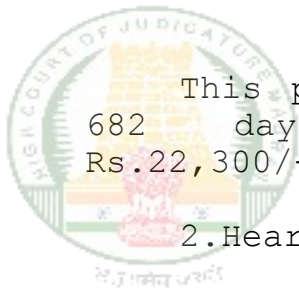

Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to set aside the decree and judgment of Motor Accident Claims Tribunal - Special District Judge of Tanjore dated 22.01.2016 in M.C.O.P.No.361/2014 and allow the appeal.
