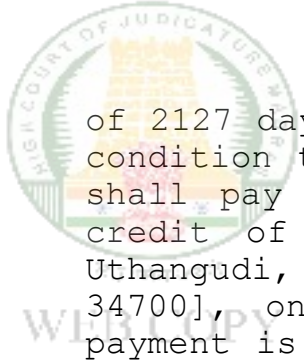
PRAYER IN W.A. (MD) SR.No.39992 of 2012:

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari call for the records pertaining to the order passed by the Labour Judge, Madurai in I.D.No. 174 of 1997, dated 09/10/2007 and quash the same as illegal and invalid and thus render justice.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.A.P.MUTHU PANDIAN, Advocate for the petitioner, the court made the following order:-
