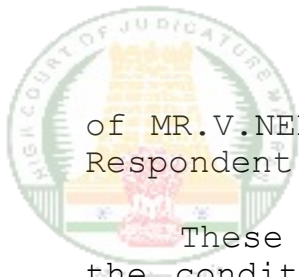
Prayer in CRL MP(MD). 8910/ 2018 IN CRL OP(MD).NO.14053/18 :
