ORDER

This criminal original petition has been filed challenging the order of the learned Judicial Magistrate No.II, Kumbakonam dated 29.06.2018 made in Cr.M.P.No.6879 of 2018 filed under Section 156 (3) Cr.P.C., refusing to direct the respondent police to register an FIR, on the ground that cognizable offence has not been made out.

2.The learned Government Advocate (Crl.Side) would submit that the respondent police have conducted enquiry based on the complaint given by the petitioner and they have found that the entire incident as projected by the petitioner is false.
