PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in S.C.No.55 of 2013 on the file of the learned Subordinate Judge, Kuzhithurai for the offences punishable under Sections 342, 323, 307 I.P.C read with Section 34 I.P.C, seeks anticipatory bail.

2.The petitioner was absent during the trial in S.C.No.55 of 2013 on the file of the learned Subordinate Judge, Kuzhithurai. Therefore, Non-Bailable Warrant came to be issued.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

The concerned Subordinate Judge is directed to consider the same on merits and pass orders on the same day.
