This petition is filed to extend the time limit of the petitioner's surrender and execute sureties in Crl.O.P(MD)No.15337 of 2018, dated 25.09.2018.

2.Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3.It is seen that there was a delay of more than 15 days to execute the sureties and surrender before the Trial Court by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1,000 (Rupees one thousand only) to the credit of Dt.Siddha Med Officer CCRI PKM, State Bank of India, Periyakulam, A/c.No.10767823177, IFSC Code: SBIN0000898, MICR Code: 625002601, and on such deposit, the time for surrender and to execute the sureties is extended by two weeks from the date of receipt of a copy of this order.



5.The petitioner is directed to produce the receipt of deposited amount at the time of executing the sureties.

6.Accordingly, this Criminal Miscellaneous Petition is allowed.
