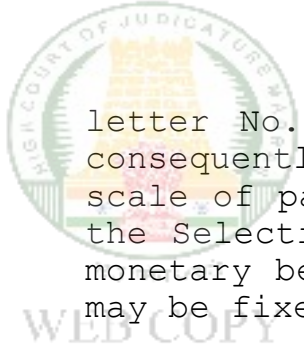

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari and Mandamus calling for the records of the second respondent i.e the Managing Director, TAMILNADU MINERALS LTD., Chennai relating to his



letter No. RC. 504/E4/14 dated 11.02.2014 and quash the same and consequently direct the first and second respondents to fix the scale of pay in respect of the petitioners as Rs.9300-34800+4200 in the Selection Grade notionally with effect from 01.01.2006 and with monetary benefit from 01.04.2013 within a specified time frame that may be fixed by this Honble High Court.
