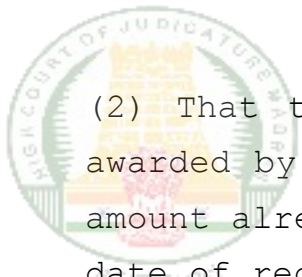
Prayer:-
