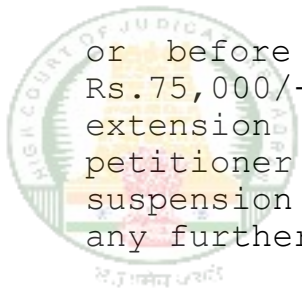

2.Heard the learned counsel on either side.

3.At request of the petitioner and the reasons stated by the learned counsel for the petitioner that the petitioner is not able to pay the amount of Rs.1,50,000/- immediately, this Court modifies the order dated 30.07.2018 as under:

4.The petitioner shall deposit a sum of Rs.75,000/- to the credit of S.I.C.No.330 of 2014 on the file of the learned Judicial Magistrate No.II, (Fast Track Court Magisterial Level), Madurai on



or before 27.08.2018 and shall deposit the balance amount of Rs.75,000/- on or before 03.09.2018. No further modification or extension of time will be granted to the petitioner. If the petitioner fails to comply the above condition, the order of suspension of sentence shall stand recovered automatically without any further reference of this Court.
