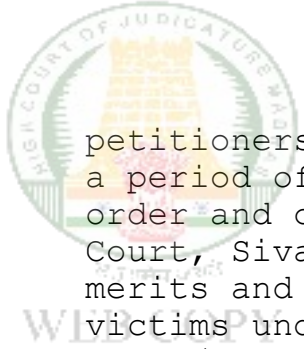

PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The allegation made against the petitioner is that there was only a wordy quarrel between the petitioners and the de facto complainant.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this court cannot be issued routinely in all cases. Therefore, the



petitioners are directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Special Court for PCR Court, Sivagangai, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Sections 324, 506(ii) I.P.C and Section 3 (1) (r) (s) of SC/ST Act (Prevention of Atrocities) Amendment Act, 2015.

3. This criminal Original Petition is disposed of with the above directions.
