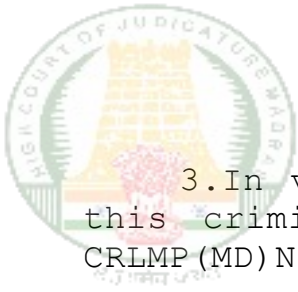

2. Law on this issue has been settled by the Division Bench of this Court in **M. Krishnamurthy and Others Vs. Sub Divisional Magistrate cum Revenue Divisional Officer, Krishnagiri and another** reported in **2017 (1) MLJ (Crl) 257**, wherein this Court has held that challenge of summon issued under Section 107 of the Criminal Procedure Code, cannot be made directly before this Court.
