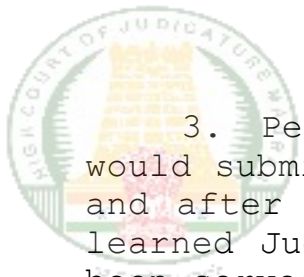

ORDER

This Criminal Original Petition has been filed to transfer the investigation in Crime No.20 of 2018 from the fourth respondent police to any other competent investigating officer.

The learned counsel for the petitioner would submit that the First Information Report itself came to be registered only pursuant to the orders passed by the Jurisdiction Magistrate under Section 156(3) of Cr.P.C. Even subsequent to the registration of the First Information Report, no investigation was made by the fourth respondent and therefore the present petition



3. Per contra, the learned Government Advocate (Crl.Side) would submit that the fourth respondent has investigated the case and after investigation closure report has been filed before the learned Judicial Magistrate No.I, Madurai and RCS notice has also been served on the petitioner.
