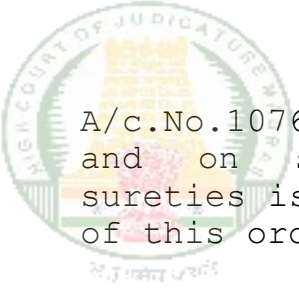

This petition is filed to extend the time limit of the petitioner's surrender and execute sureties in Crl.O.P(MD)No.17606 of 2018, dated 03.10.2018.

2.Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor for the respondent.

3.It is seen that there was a delay of more than 5 days to execute the sureties and surrender before the Trial Court by the petitioners.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1,000 (Rupees one thousand only), to the credit of Dt.Siddha Med Officer CCRI PKM, State Bank of India, Periyakulam,
