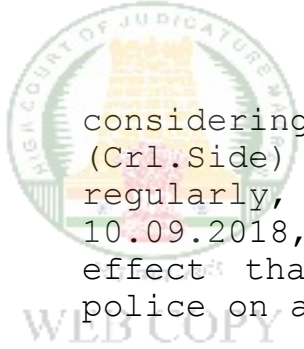
This Petition has been filed to relax the condition imposed in Crl.O.P.(MD)No.16170 of 2018, dated 10.09.2018.
