Time is granted further for a period of two weeks from the date of receipt of a copy of this order.

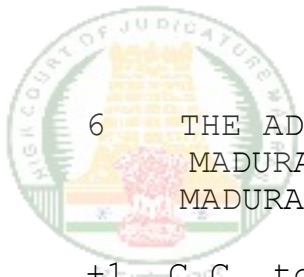
