Therefore, the petitioners are directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned II Additional District and Sessions Judge cum PCR Court, Tirunelveli, Tirunelveli District, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Sections 294(b), 323,



506(ii) of IPC and Section 4 of TNPHW Act r/w. 3(1)(r), 3(2)(va) of SC/ST Act (Prevention of Atrocities) Amendment Act, 2015.

2. This criminal Original Petition is disposed of with the above directions.
