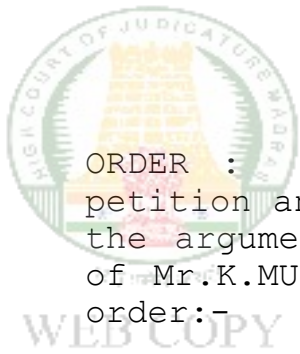

PRAYER IN WA(MD) No.SR51140 of 2018

Set aside order of the learned Judge dated 23.06.2017 in WP.(MD)No.11733 of 2010 and allow the writ petition as prayed for and to pass such further orders.

Prayer in WP(MD). 11733/ 2010 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARI, after calling for the records from the 1st Respondent relating to the impugned order dated 25-03-2009 in A.T.A.No.680 (13) 2003, quash the same.



ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.S.ARUNACHALAM, Advocate for the petitioner and of Mr.K.MURALISANKAR, Advocate for R2, the court made the following order:-
