ORDER : The Court Made the following order :-

The petitioners apprehends arrest at the hands of the respondent police in P.R.C.No.45 of 2012 on the file of the learned Judicial Magistrate , Melur for the offences punishable under Sections 417, 376, 109, 506(i) pf IPC and Section 4 of TNPHW Act , seek anticipatory bail.
