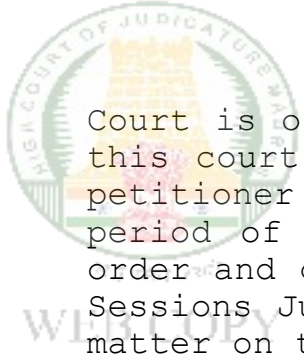

O R D E R

This Criminal Original Petition has been filed to direct the learned II Additional District and Sessions Judge (PCR) Court, Tirunelveli to consider the bail application of the petitioner on the same day of their surrender in Cr.No.62 of 2018, which is registered for the offence under Sections 147, 148, 294(b), 324, 506 (2) of IPC r/w Section 3(1)(r), 3(1)(s) and 3(2)(va) of the Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015, by the second respondent Police.



Court is of the view that the usual directions that were issued by this court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court, within a period of two weeks, from the date of receipt of a copy of this order and on such surrender, the learned II Additional District and Sessions Judge (PCR) Court, Tirunelveli, shall deal and dispose the matter on the same day on merits and in accordance with law.

3. In due compliance of Section 15-A of the SC/ST Act, the petitioner shall serve advance notice of surrender and bail two clear days before the intended date of surrender enclosing additional copies on the Special Public Prosecutor of the concerned Court and the Special Public Prosecutor shall intimate it to the defacto complainant through the respondent police.

4. This criminal Original Petition is disposed of with the above directions.
